- 9) I state that if the information given in the application and affidavit founds incorrect or false, the Sports Certificate Verification Report is liable to be cancelled.
- 10) I state that the sports certificate is issued by the office bearers of the State Sports Association / National Sports Federation. I state that the Form No. 2/3 has been issued by the President / Secretary of the Association.
- 11) I state that in case of any dispute between the fractions of the State Sports Association / National Sports Federation, the decision taken by the Directorate of Sports & Youth Services, Maharashtra State, Pune will be final and binding upon me.
- 12) I state that I have enclosed my other sports certificates, training certificates pertaining to participation and merit in the '.....' game.
- 13) I state that the State Sports Association / National Sports Federation is responsible for the maintaining the record of the tournament and in case, the record is not made available by my association, I am aware that the verification of the sports certificate is liable to be rejected.
